

## DECLARATION OF RESIDENCY – ATTN: CORPORATE ACTIONS

The common shares (“**Common Shares**”) issuable pursuant to a prospectus dated February 2, 2011 to qualify a special dividend of Prosperity Goldfields Corp.’s (the “**Issuer**”) common shares by Evolving Gold Corp. (“**Evolving Gold**”) will not be registered under the laws of any foreign jurisdiction, including the United States Securities Act of 1933, as amended. Consequently, no Common Shares will be delivered to any registered or beneficial holder of Evolving Gold common shares who is, or who appears to Evolving Gold, the Issuer or Computershare Trust Company of Canada (the “**Trustee**”) to be, a non-resident of Canada within the meaning of the *Income Tax Act* (Canada).

Evolving Gold and the Issuer reserve the right to make a determination of residency in their sole discretion. **If a holder fails to declare that they are a resident of Canada by completing the appropriate box below and returning this declaration to the Trustee on or before March 2, 2011, they may be deemed to be a non-resident on that date.** With respect to registered holders of Evolving Gold common shares whose address on the Evolving Gold shareholder register on February 16, 2011 (the “**Record Date**”) is in Canada, Evolving Gold and the Issuer may consider such holders to be residents of Canada. **If a broker or other Depository participant fails to provide the necessary declaration of Canadian residency on behalf of their clients on or before March 2, 2011, the applicable beneficial holders of Evolving Gold common shares may be deemed to be non-residents on that date.**

The following form is for use by registered holders of Evolving Gold common shares. If you hold your common shares in Evolving Gold through a brokerage or other account through CDS Clearing and Depository Services Inc., the broker or other Depository will need to respond to the residency declaration on your behalf.

All registered holders of Evolving Gold common shares must complete this box.
